## Lawn Care

- An alternative to professional lawn care was mentioned as a possibility of using neighborhood kids.
   While everyone agreed it would be a great idea, insurance issues, uniformity and management of kids was addressed.

#### Admin Report

- Tammy reported several houses in the neighborhood are for sale. She will work with Dave to make sure the realtors have a dues current letter available at closing with a copy of the covenants.
- Tammy will supply Dave with realtor info so our association dues will reflect correct information on the MLS listing.
- The Board has requested the ACC send a letter to a homeowner whose previous request has been deemed incomplete.

#### Website

The Board decided that we would make such a small amount of money that we would only charge a fee for anyone wanting to advertise from outside Hidden Valley.
