# Hidden Valley Homeowners Association Meeting Minutes September 2, 2025

#### Call to Order

- The meeting was called to order at 7:03pm.
- Roll call was conducted, and the meeting was attended by: Rick Fryar, Dave Thiede, Sue Hill, Dana Frey, Carissa Erie, Sheryl Francis, Brian Bluhm & Lydia Werner (online).
- Four residents attended the meeting. One in person and three online.

#### Approval of the Agenda

- Brian Bluhm reviewed the meeting agenda.
  - Rick Fryar moved to approve the agenda and Dave Thiede seconded the move.
  - The agenda was approved.

## Financial Report (Treasurer Dave Thiede)

- Dave told the meeting that the association is building up their bank account again.
- There is currently \$13,842.59 in the association's bank account.
- A resident attendee asked, in the course of repairing the roads, if the city can compensate us for redoing the mailbox pads that we recently replaced and paid for.
  - The board answered that the city didn't redo any of the new ones we did, they only replaced the old concrete pads.
- Dave reminded the attendees that anyone who would like his financial spreadsheets can email him.
- Next, Dave spoke about the Association Dues.
  - He stated that there are 18 outstanding dues.
  - o Some are a couple of years old, totaling around \$400 past due each.
  - There is not much the association can do, but we can put a lien on the property for when they want to sell.

- o We email the past due residents, and we send registered mail as well.
  - Registered mail is expensive, and it can be refused by the homeowner.
- We have recuperated a few late Dues.

### Maintenance Report (Sheryl Francis & Brian Bluhm)

- Brian informed the meeting that Romeo is the lawn maintenance company we are currently using.
  - They seem to be doing fine, but Brian is wondering if they have a license to spray because there have been no signs posted, which they are supposed to do.

## Architectural Control Committee (ACC) Report (Avalon Hutchinson/Brian Bluhm)

- Brian informed the group that he will go over this section as Avalon couldn't make it tonight.
- Dana asked if there is a full committee?
  - o Brian There is only Avalon currently.
  - o We need more people on the ACC, and board members can't be on it.

## <u>Violations Report</u> (Brian Bluhm)

- There were 8 violations this summer:
  - o stored car
  - o tall weeds
    - Weeds can't be over 8in by city code.
      - goes to city for them to deal with.
  - o campers
  - o trailers
  - o stumps
- An attendee asked if residents can we take trees down if they are diseased?
  - Answer Yes
- Dave suggested the association review the ACC guidelines again.

## **Unfinished Business** (Brian Bluhm)

- Islands we need to firm up the quotes for getting the islands redone.
  - We need to nail down the timeline as well.

- A lot of the islands need a rock refresh, and some need to be completely redone.
  - We will get quotes on labor for rerocking.
- o Brian will publish a map on the HVHA website with the island's number and info on when they were or will be done.
- The city needs to put more dirt in the islands after the roadwork.
- An attendee asked about the overgrown trees near the Hidden Valley monuments in someone's yard. Is it HVHA or private property?
  - o Answer- Its ours, and we can clean it up and rip down the overgrown trees.
- A lot of islands will be done next year.
  - o Islands 10 and 7 will be redone, trees will come out and new plants and rock will be added.
- The 72<sup>nd</sup> Monument needs to be done, and we want to see if we can get it done this year.

#### **New Business**

- Dave should we put up a survey on what residents think of the pavement work?
  - o Rick- I can put it on the HVHA website.
